I understand that the Boulder JCC J-Teen Summer Adventure Programs are a group experience and that my full participation, with a positive attitude, in all activities, is important to overall success of the weekend. I will treat others with *Kavod* (honor and respect). I have read the following rules, designed to promote the health and safety of all retreat participants, and have indicated my complete acceptance by my signature and that of my parent/guardian.

- I will not bring electronics with me.
- I will not go into the opposite sex's tent.
- I will not possess, consume, or distribute alcoholic beverages.
- I will not possess, use, or distribute any illegal drug or drug paraphernalia.
- I will not smoke or consume or distribute tobacco products at any time during the activity.
- I will attend and participate fully in the entire program, unless otherwise agreed upon with the director of the retreat program.
- I will arrive on time, stay until the end, and remain with the group at all times.
- I will not bring or use any weapons, firearms, or anything that may be construed as a weapon.
- I will not commit any illegal act. I understand that vandalism, disturbing the peace or other inappropriate behavior as determined by the adult leadership will not be tolerated.
- I understand that I will have to pay for any damage that I cause.
- I will abide by any curfew announced by the Boulder JCC staff.
- I will not participate in any activities that could be deemed as hazing, sexually harassing, demeaning, or hurtful.
- I agree to refrain from inappropriate sexual behavior.

I understand that these rules of behavior apply from the time I leave the Boulder JCC for activity, during the program itself, and until I return to the Boulder JCC.
